### Emnets undervisnings- og vurderingsform

On-site internship at selected host institution. Total workload in the internship workplace is stipulated to 12 weeks, 5 workdays per week, 37,5 working hours per week.

In addition to the working hours dedicated to the internship workplace, the students submit a final report and present the findings in a seminar at UiB at the end of the internship. The final report is a 5000 word (+-10%, excluding the title page, table of contents, references, tables, and all attachments) internship report delivered by the end of the internship semester. The report is graded pass/fail.

### Evalueringsmetode(er)

Student survey and conversations between students and course responsible

### Sammendrag av studentene sin evaluering

Seven out of 16 students responded to the survey.

All but one respondent felt that the internship contributed to their learning, and that they gained academically and in terms of new skills. Hence, all but one student would recommend the internship to other students.

Most students felt that knowledge from methodological courses was useful during their internship, whereas theoretical knowledge from previous courses was generally deemed of limited relevance.

Students liked the practical work experience, and enjoyed seeing how their academic knowledge can benefit an actual organization.

In their self-evaluation, students highlight that they would liked to be more prepared after experiencing a steep learning curve, and had a clearer view of the tasks and expectation beforehand. Possibility to attend the course seminar remotely would also have been appreciated.

### Emneansvarlig sin evaluering

The application process and evaluation process prior to the internship ran smoothly, and no problems arose during the internships. Students executed a wide range of tasks at their organizations, and the midterm meetings with students and their internship organizations, as well as course seminar, worked well. At the seminar, students contributed constructively on each others' drafts.

The final internship reports generally received a very good evaluation by the internal and external sensors.

The partner organizations were very happy with the internship and all agreed to continue their participation in the next round (H25).

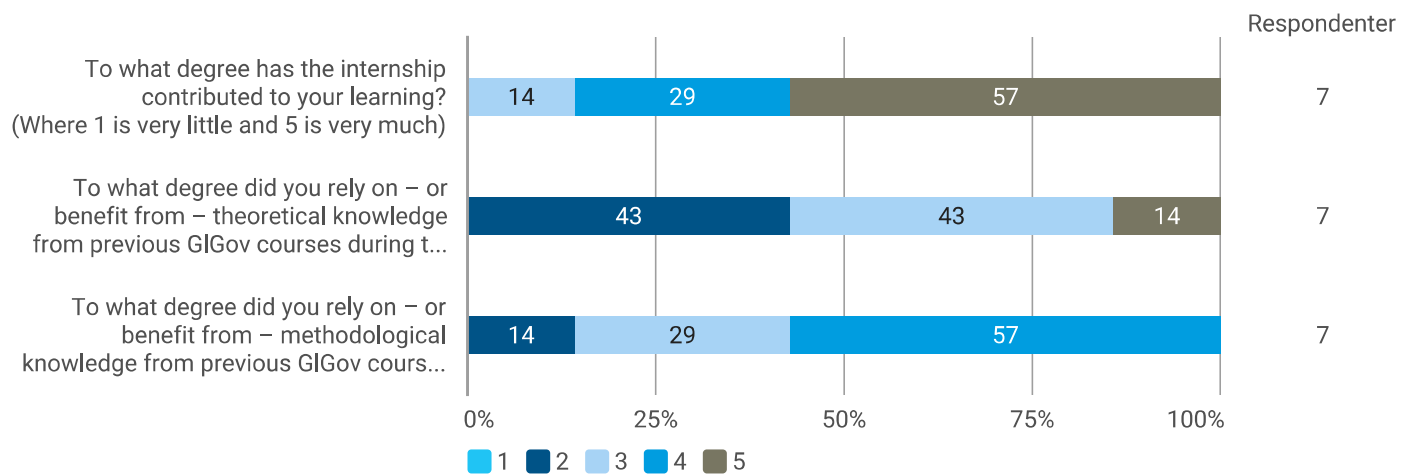
**Evt. kommentar til karakterfordeling**

**Mål for neste evalueringsperiode- Forbedringstiltak**

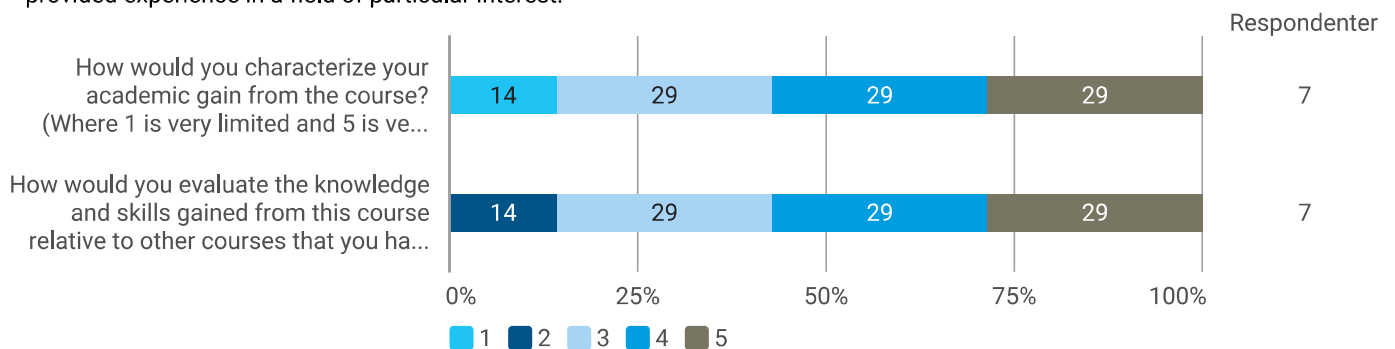
In response to students' feedback, as well as upon request of internship organizations, the following changes will be implemented as of next round (H25):

- Three additional internship places will be added.
- Longer application deadline.
- The length of internship extended to 14-16 weeks.
- The compulsory seminar will be replaced by written peer feedback on draft internship reports, to accommodate the request of students in internships outside of Bergen.



### Is there any part of the internship course that you are especially satisfied with?

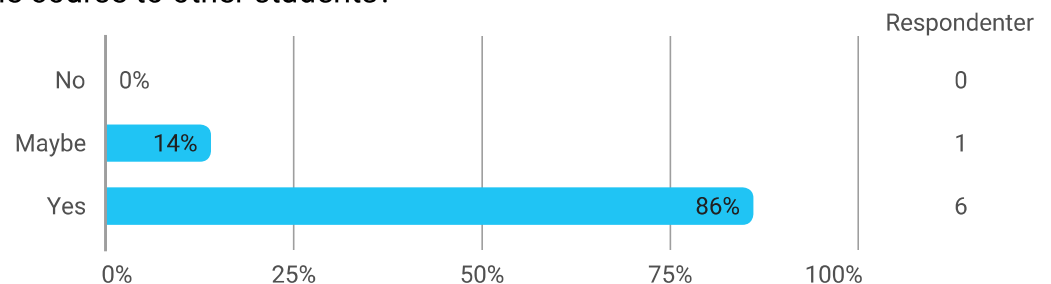
- I have been able to use my knowledge both from my bachelor's and master's courses and seen how my experience can benefit an organisation.

### If you were to do an internship again, what would you do differently?

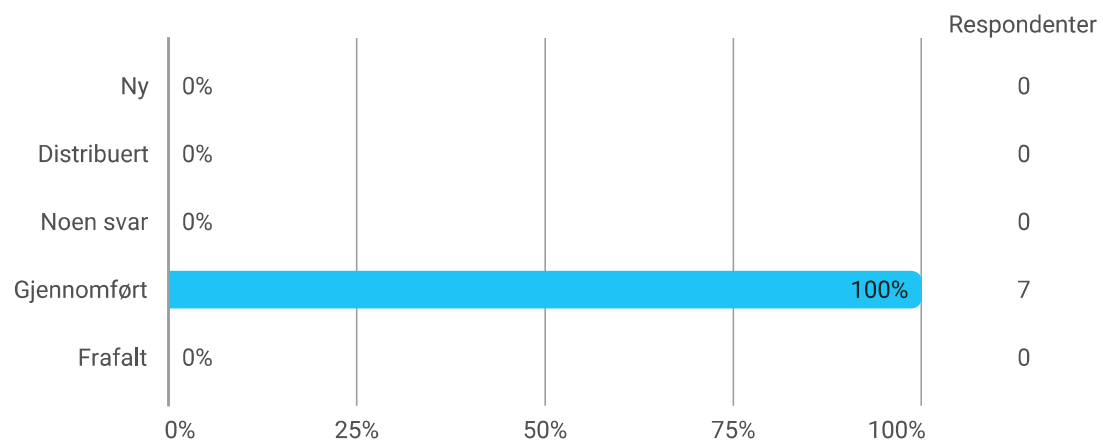
- Maybe I would make an effort to complete more individual tasks, rather than attend a lot of meetings. Although I have really enjoyed the meetings.
