Emnets undervisnings- og vurderingsform

In the GIGov master students third semester- they chose one of three directions: A self designed semester (30 ECTS), an internship (30 ECTS) or mobility (30 ECTS). GOV 372 is a 10 ECTS course that forms a part of the self-designed semester. The course is organized around the development of a student paper of 20 pages. In collaboration with mentor/supervisor, the student chooses literature and develop av research paper on a selected topic. The core idea is for students interested in research to work closely with a supervisor/mentor and learn the "trade" of writing an academic paper.

10 ECTS may be designated as self-organized study at the Department of Government where the student conducts a self-taught course supervised by the MA program.

Learning Outcomes: A student who has completed the course will be able to recognize key theoretical perspectives and their applicability to global challenges. Further understand when and to what problem sets a particular approach is most relevant. Candidates understand key choices, ethical standards and quality criteria in academic writing.

A candidate is able to organize curriculum and integrate different theoreies and methods an empirical analysis, present key empirical and theoretical insights to other students. Finally, collect, align abstract theories and concepts, empirical knowledge about policy responses to global challenges, and the political science analysis of different governance approaches

Oppfølging fra tidligere evalueringer

The course was offered for the first time Fall semester 2024

Evalueringsmetode(er) Written evaluation

Sammendrag av studentene sin evaluering

One student of the (22 students in total) opted for the opportunity to organize and create their own semester. We believe that in comaprison to internships and mobility, this direction was not presented clearly enough as an alternative and we have taken measures to improve that.

The student evaluation point to limited choices as a key impediment. However, both the Phd course (lawtransform) and the course offered by Glode (gender and development) were rated very positively.

Unfortunately, the self-organized course (GOV 372) was the part that the student was the least satisfied with, citing lack of repertoire with mentor/supervisor and feeling of not being given enough direction.

Emneansvarlig sin evaluering

It is concerning that the student felt that it was difficult to communicate concerns and anxieties to mentor /supervisor. Better guidelines for expectations of candidates and mentors/supervisors were clearly needed.

It is very encouraging that the candidate find that taking courses from other departments greatly enriched her experience.

Evt. kommentar til karakterfordeling

Only one student opted for this option. The candidate passed.

Mål for neste evalueringsperiode- Forbedringstiltak

- 1. We will present this semester option in a more clear and precise manner for the next cohort and not as a "default option"- work is already underway with webpages etc.
- 2. We are working with four other global (and English speaking) master programs to offer more course options and alternatives to chose from. While students should be able to chose freely, we will provide a list of recommended courses
- 3. We will improve the guidelines and expectations for the research paper in Gov 372, hereunder clarify the role of mentor/supervisor more clearly.

 - 3. GOV372 Self-Organized Course 10 ECTS


Which topic of the semester did you find to be the MOST interesting and relevant for your masters degre?

· I was able to take courses from another department and the course went so well.




In your opinion, how do you think this semester can be improved?

Do you agree that we can use your answers for information purposes on our website?




What was the best thing about the self-organized semester? (Feel free to write about a good experience or cool courses you have taken)
