



Teaching methods:


In the lectures we used different ways to recap what had been covered the previous week. Which did you find most useful?

Is there any part of the course that you are especially dissatisfied with?

- Overall, the level of difficulty/complexity was not that high; that might be due to the introductory character, or because it was a Bachelor course, but I think it could be interesting to add more complexity by discussing different theories and approaches to tackle questions of research instead of just listing
- I found the second part much more interesting, but the first part as a necessary background to understand the latter.
- The lectures have been a bit boring and not very inspiring.
- When we read the readings before the lecture, we don't learn a lot of things during the lecture
- I found some of the literature quite similar, and quite eurocentric. I would like to know more about the labour markets in USA, Australia, Africa etc.

In your opinion, how could this course be improved?

- As mentioned before, I would want to have more discussion on theoretical questions. More discussion of the theories. Concerning the readings, there were a lot of textbook texts, which is fine for an introduction, but reading contemporary published articles with contemporary theories and methods and discussing them critically might be interesting as well
- It would be nice to visit NAV (this year it wasn't possible but it is not fault of our lecturer).
- You already said it at the beginning, that this course only targets western countries because there is not so much time. Personally I would have liked to know if there are differences to other non-european countries
- I would have liked more to discuss the issues of labour market itself, those who fall outside but still work, issues of regulation/irregulation, black market and such.
- A more explicit use of economic and sociological theories to understand the dilemmas in LMP in different perspectives.
- Add some color to the lectures. Professor Picot is clearly very knowledgeable, but I do not think he conveys in the most inspiring way.
- Less readings. The articles were too many
- I think maybe making it more practical, with more examples could be useful.
- By the last sentence in the previous box.
- Starting with the readings to the SECOND topic instead.... these + the lecture explained/gave insight into the subject as such. They were rather simple and "inviting", especially since they showed to different points of departure on the same topic.
